If you post it in Hong Kong, you may use the mailing label in the reply form and need not affix a stamp when returning your reply form. Otherwise, please affix an appropriate stamp.

If the Company does not receive the enclosed reply form or does not receive a response indicating the objection from you by 10 February 2017 and until you inform the Company c/o the Hong Kong Share Registrar by reasonable notice in writing according to the relevant laws and regulations, you are deemed to consent to website communication only, and a notification letter of the publication of the Corporate Communications on website will be sent to you.

You have the right at any time by reasonable notice in writing to the Company c/o the Hong Kong Share Registrar or by email to <a href="mailto:dahsingbanking.ecom@computershare.com.hk">dahsingbanking.ecom@computershare.com.hk</a> to change the choice of means of receipt of the Corporate Communications.
