  - Trading Shanghai A Share 0.4% of transaction amount, minimum RMB240

- 0.00696% of the consideration of a transaction per side · Securities Management Fee 0.002% of the consideration of a transaction per side
  - · Transfer Fee 0.06% on face value per side
  - · Stamp Duty 0.1% of the consideration of a transaction on the seller
