- 1. 電話理財服務受個別收款人(除跨境理財通(北向通)已綁定的「一對一」收款戶)所被設定之每日轉賬限額所限。Phone Banking Service shall be subject to the Daily Transfer Limit assigned to individual beneficiary (except for Cross-boundary Wealth Management Connect (Northbound) dedicated one-to-one beneficiary account).
- 2. 網上理財服務 (個人客戶) 之轉賬限額如下: The Transfer Limits for e-Banking Service (Personal Customer) are stated as below:
- 2.1 轉賬至已登記的大新銀行/其他本地銀行第三者戶口之最高每日總轉賬限額為HK\$1,000,000;
  - The maximum Daily Transfer Limit for Fund Transfer to registered third party accounts of Dah Sing Bank/ Other Banks in Hong Kong is HK\$1,000,000;
- 2.2 以保安認證服務轉賬至未經登記戶口之每日最高總轉賬限額為HK\$65,000;
  - The maximum Daily Transfer Limit for Fund Transfer to non-registered accounts via Security Authentication Service is HK\$65,000;
- 2.3 轉賬至大新銀行(中國 ) 有限公司戶口之最高每日總轉賬額為HK\$500,000。 ( 有關詳情·請參閱本行網站 www.dahsing.com )
- The maximum Daily Transfer Limit for Fund Transfer to the accounts in Dah Sing Bank (China) Limited is HK\$500,000. (For details, please refer to the Bank's website www.dahsing.com)
- 2.4 小額轉賬之每日最高總轉賬額為HK\$10,000。
- The maximum Daily Transfer Limit for Small-value Transfer is HK\$10,000.
