

General Terms and Conditions of "Apple Store Spending Reward" Promotion ("this Promotion"):

- 1. The promotion period of the Promotion is from 1 Mar 2024 to 30 Apr 2024 (both dates inclusive) ("**Promotion Period**"). Spending is calculated based on relevant transaction dates as recorded by Dah Sing Bank, Limited ("Bank").
- This Promotion only applies to the cardholders ("Eligible Cardholders") holding a Principal Card or Supplementary Card of a Visa Card or Co-brand Card ("Eligible Visa Card") issued by Dah Sing Bank, Limited ("Bank").
- 3. Eligible Cardholders cannot simultaneously enjoy "Visa Card Flash Offer 6% Cash Rebate" of this Promotion and the rewards of the other Dah Sing Credit Card Spending Promotions.

- 11. The Bank is not the supplier of products / services offered to the Eligible Cardholders by the Participating Merchant and shall not be responsible for any matters in relation to the quality and availability of such products / services. The Bank makes no representation or guarantee in respect of such products / services. Any enquiries, comments or complaints about products / services should be directed to the Participating Merchant.

- 17. These Terms and Conditions shall form part of any applicable agreements governing the use of the Eligible Cards and shall be construed accordingly. In case of any conflict between these Terms and Conditions and such agreements, these Terms and Conditions shall prevail.
- 18. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong. Any dispute arising under these Terms and Conditions shall be subject to the non-exclusive jurisdiction of the courts of Hong Kong.
- 19. A person who is not a party to these Terms and Conditions may not enforce any of their provisions under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong).
- 20. In the event of any discrepancy between the Chinese and English versions of these Terms and Conditions, the English version shall prevail.

The Bank will not issue any notification if an Eligible Cardholder fails to register successfully due to provision of incorrect information (if applicable).
