- 5. A person who is not a party to these Terms and Conditions may not enforce any of their provisions under the Contracts (Rights of Third Parties) Ordinance (Cap 623 of the Laws of Hong Kong).
- 6. In case of any discrepancy between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.

## Terms and Conditions for the Welcome Offer of 328 Business Account:

- 7. The promotion period for the Welcome Offer of 328 Business Account is from 2 Jan 2024 to 30 Jun 2024 (both dates inclusive) ("328 Business Account Promotion Period").
- 8. Only customers who fulfill all the following criteria ("Eligible 328 Business Account Customers") are eligible for the HKD200 Account Opening Welcome Offer ("Account Opening Reward"):
  - a. Submit a 328 Business Banking Online Application via the Bank's website (by entering the Bank's website via YOOV platform and inputting the promotion code "YOOV2024" in the 328 Business Banking Online Application Form) during the 328 Business Account Promotion Period;
    - b. Successfully open a 328 Business Account (including both Current Account and Savings Account) at the Bank during the 328 Business Account Promotion Period; and
    - c. Did not maintain any 328 Business Account at the Bank within twelve months prior to the relevant application for account opening as referred to in Clause 8(b) above.
- 9. The Bank will credit the Account Opening Reward to the 328 Current Account of the Eligible 328 Business Account Customer on or before 30 Sep 2024. The relevant 328 Business Account must remain valid when the Account Opening Reward is to be credited. - 12. Only customers who fulfill all the following criteria ("Eligible SME Loan Customers") are eligible for the HKD200 Welcome Offer of SME Loan ("SME Loan Reward"):
  - a. During the SME Loan Promotion Period, enter the Bank's website via the hyperlink in the YOOV platform, input the promotion code "YOOV2024" in the SME Loan Enquiry Appointment Form ("Form") and complete the Form to make an application appointment;
  - b. Successfully apply for a 328 SME Express Money Installment Loan, a 328 SME Tax Loan (collectively, "SME Loan") (but excluding 90% SFGS Loan, 100% SFGS Loan and SME Loan under the Pre-approved Principal Payment Holiday Scheme) during the SME Loan Promotion Period; and
  - c. Have the SME Loan successfully approved and drawn down from the 328 Business Account (which must also be designated as the repayment account) on or before 31 Aug 2024.
- 13. Only customers who fulfill all the following criteria ("Eligible YOOV EAT Customers") are eligible for the HKD200 Welcome Offer of YOOV EAT Pre-approved SME Loan ("YOOV EAT Reward"):
  - a. During the SME Loan Promotion Period, enter the Bank's website via the hyperlink in the YOOV platform, input the promotion code "YOOVEAT2024" in the Form and complete the Form to make an application appointment;
    - b. Successfully apply for a YOOV EAT Pre-approved SME Loan during the SME Loan Promotion Period; and
    - c. Have the YOOV EAT Pre-approved SME Loan successfully approved and drawn down from the 328 Business Account (which must also be designated as the repayment account) on or before 31 Aug 2024.
