

General Terms and Conditions

- The promotion period is from 6 September 2017 to 31 October 2017, both dates inclusive ("Promotion Period").
 Spending Period is based on transaction date. Transaction date is based on the record of Dah Sing Bank, Limited (the "Bank").
- 2. The Promotion is applicable to customers holding Principal Card and Supplementary Card ("Eligible Cardholder") (including the Bank's UnionPay Dual Currency Credit Card) or Co-brand card issued by the Bank ("Eligible Card") except Cash Card, Corporate Card, Purchasing Card, Spending Card, Business Card, Gift Card, Private Label Card, "Happy Family" Octopus AAVS account and Balance Transfer Account ("Non-eligible Cardholder").
- 3. Eligible transaction refers to transaction made at Hong Kong Suning stores and/ or Hong Kong Suning Online Shop (the "Online Shop") ("Participating Merchant") and with sales slip and/or online transaction confirmation record ("Eligible Transaction"). Apple Pay Eligible Transaction refers to contactless or in-App retail transactions made via Apple Pay by Eligible Card ("Apple Pay Eligible Transaction"). Exclude cash coupons, installment transactions, split transactions, spending without sales slips / online transaction confirmation record / unposted / cancelled / refunded and any unauthorized transactions. The Bank reserves the final decision of the Eligible Transaction definition.
- 4. Eligible Cardholder must present and settle full payment with Eligible Card in order to enjoy the offer.
- 5. All offers cannot be exchanged to cash, other products, services or discount offer; also cannot be transferred to third parties or other account or withdrawn by cash advance.

- 16. In the event of discrepancies between the Chinese version and English version of these Terms and Conditions, the Chinese version shall prevail.
