- For the avoidance of doubt, the Company does not accept any special instructions written on this proxy form.
- Shareholders or proxies who attend the meeting in person will each receive **ONE** souvenir as a token of the Company's appreciation. If a shareholder is also appointed as proxy/proxies of other shareholder(s), or a proxy represents multiple shareholders, the number of souvenir each of the aforesaid shareholder or proxy will receive is limited to **ONE**.
