

Terms and Conditions of 10% Discount on ANA Air Ticket Purchase Offer ("ANA Air Ticket 10% Discount Offer"):

- The ANA Air Ticket 10% Discount Offer runs from 1 Jun 2025 to 31 Aug 2025 (both days inclusive) ("Booking Period").
- The ANA Air Ticket 10% Discount Offer is only applicable to customers who are holding Principal Card or Supplementary Card of Dah Sing ANA World Mastercard ("Eligible Card") issued by Dah Sing Bank, Limited ("Bank") ("Eligible Cardholder").
- 3.
