

**Terms and Conditions of Doraemon Pop-up Store Promotion 2025 ("Promotion"):**

1. The promotion period for the Promotion is from 8 Aug to 7 Sep 2025 (both dates inclusive) ("**Promotion Period**").
2. The Promotion only applies to customers holding Principal Card or Supplementary Card of the credit card or co-brand card ("**Eligible Card**") issued by the Dah Sing Bank, Limited (the "**Bank**") ("**Eligible Cardholder(s)**"). 4. Eligible Cardholder must settle full payment with Eligible Card to enjoy the Offers. Payment made via eWallet, including but not limited to Apple Pay, Google Pay, Samsung Pay, Alipay HK, WeChat Pay HK, are eligible, while PayPal or PayMe payment are excluded.
