Q1. How to participate in the "Viva Lucky Draw Craze" Game Promotion?

Q2. I got a message regarding eToken(s) of "Viva Lucky Draw Craze" Promotion, how could I use it / them?

Cardholder is required to login Mobile Banking and select "Rewards" or click the gift icon at the top right corner on homepage to enter "My Rewards", then click "eToken Details" on the "Viva Lucky Draw Craze" Promotion and "Go" to use the eToken within eToken Validity Period and play the game.



Q3. Is registration required for "Viva Lucky Draw Craze" Promotion?

Registration is not required for this promotion. You can simply participate in the Game with valid eToken(s).

Q4. I do not have Dah Sing Mobile Banking, how to participate in the Game?

Cardholder can participate in the Game after successfully registration and login Dah Sing Mobile Banking. Please <u>click here</u> for the e-Banking / Mobile Banking registration demo.

Q6. Why does my smartphone fail to load the Game Site?

Cardholder is required to use the mobile device with the latest version of Dah Sing Mobile Banking (version 3.7.2 or above) and one of the following browsers to participate in the Game: Edge 79+, Firefox 44+, Chrome 56+, Safari 11+, Safari on iOS 11+ and Android browser 91+.



Q7. Are the prizes in the lotus leaf different?

The Prizes in the each lotus leaf are different. After start the Game from Game site, Cardholder is required to let go the frog from the air balloon and jump on the lotus leaf within specific time (3.00s - 3.09s / 6.00s - 6.06s / 9.00s - 9.03s) participate in the lucky draw and will be rewarded one of the Prizes of the lotus leaf.

Q8. I forgot whether the eToken is used, how can I check the eToken(s) usage record?

You can follow the steps stated in Q2 to My Rewards – Viva Lucky Draw Craze in Mobile Banking to check the usage record of each eToken. The eToken will display as "Played" if you have already used the eToken.




Q9. When the cash rebate will be credited to my credit card account?

Cash Rebate will be credited to the Winner's Eligible Card account which earned eToken from Spending Offer during Promotion Period in the form of Dah Sing Credit Card free spending credit within 1 month from the date of reward. The credit card free spending credit can be used for settlement of new transactions of respective credit card and display on the coming statement.

Q10. I forgot the Prize Details and whether the eToken has won the Prize, how can I check the winning record?

Cardholder is required to login Mobile Banking and select "Rewards" or click the gift icon at the top right corner on homepage to enter "My Rewards", then click "eToken Details" on the "Viva Lucky Draw Craze" Promotion to browse the game result. If customer won a Prize with the eToken successfully, a "Prize" button and the icon of relevant Prize will be shown next to the eToken. Customer can click "Prize" to check the Prize of the eToken.





Q11. Are the eToken(s) still valid if the network connection is interrupted / lost after game started?

The eToken(s) will be recorded as used if you have entered the Game Site and pressed "Play Now" to start the game and the network is interrupted / lost after entering the game. In such, you are recommended to connect Wi-Fi for the best experience.

Q12. How can I check the earned eToken(s) and its validity period?

Cardholder can check the earned eToken(s) and its validity period from (1) Mobile Banking / e-Banking inbox message and / or (ii) email or (iii) My Rewards — Viva Lucky Draw Craze in Mobile Banking (please refer to Q2 for the steps). Please be reminded that each eToken will be valid for 14 days from the issuance date of the relevant Mobile Banking / e-Banking inbox message and / or email, whichever is earlier. eToken(s) will not be re-issued if it expires.


Q13. Can I give the eToken(s) to others for participating in the Game?

Cardholder is required to login Mobile Banking to participate in the Game, and shall not disclose personal information (e.g. login information) to others in anytime. Cardholder is solely responsible for safe-keeping the relevant eToken(s).

Q14. How can I find the eToken from Dah Sing Mobile Banking / Why the button of "eToken Details"

Customer can follow the steps stated below and login Mobile Banking to enquire "eToken Details". If the button cannot be found successfully, suggest to update the mobile App and the mobile device which is supported the latest version of Dah Sing Mobile Banking (Version 3.7.2 or above) and re-login to mobile banking.
