

Terms and Conditions for Dah Sing VIP Banking Visa Infinite Card and Dah Sing Private Banking Visa Infinite Credit Card Birthday Offer ("Birthday Offer"):

- 1. Promotion period for the Birthday Offer is from 1 Jan 2025 to 31 Dec 2025 (both dates inclusive) ("Promotion Period").
- 2.
