



### Terms and Conditions of the "Get Good Luck via Wealthy Moment in Touch" Promotion

2. "Mobile Banking" refers to Dah Sing Mobile Banking.
3. "Eligible Accounts" refers to valid VIP i-Account, Hello Kitty VIP i-Account and YOU i-Account (whether sole or joint-named) held with the Bank.
4. "Eligible Customers" refers to customers who are Hong Kong residents aged 18 or above holding valid Eligible Accounts and valid Mobile Banking accounts and have successfully completed the designated transactions (as defined in Clause 12 below) within the Promotion Period.
