Dah Sing Bank Statement on Fraudulent Post published by Social Media Scam Account

(Hong Kong, 13 June 2025) – Dah Sing Bank, Limited (the "Bank") has become aware today that a Facebook account named “牛牛財策站” operated by fraudsters (the "**Scam Account**") has published post falsely alleging that the Bank is offering certain investment offers and artificial intelligence (AI)-driven investment strategies. Customers and members of the public are invited to register with personal information through channel(s) as specified in the said post.

The Bank hereby confirms and clarifies that the Scam Account, any information published by it (including without limitation the abovementioned post) and its account holder have no connection with the Bank and its affiliates. The Bank and its affiliates shall not be responsible for any loss or damage caused by or in connection with the Scam Account, any information published by it (including without limitation the abovementioned post) and its account holder.

Customers and the public should note that the Bank will only communicate all of its promotions and information in relation to its products and services through its official channels. Customers and the public should always verify relevant offers and information through the official channels of the Bank and are reminded not to provide any login credentials and/or personal and/or financial information to or conduct any transaction via any suspicious social media accounts.

The Bank has reported the case to the Hong Kong Monetary Authority and the Hong Kong Police Force. Any customer or member of the public who has provided login credentials and/or personal/financial information or conducted any transaction via the Scam Account or channel(s) as specified by the Scam Account should promptly call the Bank's Security Alert Hotline on 2828 8159 for assistance, as well as report the case at the nearest police station, or contact the Anti-Deception Coordination Centre of the Hong Kong Police Force for assistance by calling the 24-hour "Anti-Scam Helpline 18222".

Overseas customers and members of the public who have fallen victim to the scam are advised to immediately report the case to any local police station or contact the local anti-scam hotline (if available) for assistance.
