

Terms and Conditions for Application for 328 Business Account Reward ("Promotion")

A. General Terms & Conditions

- i. "328 Customer" refers to any company customer who holds a valid 328 Business Account (including a Multi-Currency Current Account ("328 Current Account") and a Multi-Currency Savings Account ("328 Savings Account")) at Dah Sing Bank, Limited ("Bank"), but does not include any Corporate Banking Customer and Vehicle Finance Customer.
- ii. The Bank reserves the right to suspend, revise, terminate or withdraw any of the offers and interest rates mentioned herein at any time and amend the relevant terms and conditions and these Terms and Conditions at any time, without prior notice. In case of disputes, the decision of the Bank shall be final and conclusive.
- iii. In case of any fraud, abuse, reversal or cancellation of transaction(s) in respect of which any offer under this Promotion is/are awarded, the Bank reserves the right to disqualify the relevant customer from being entitled to the relevant offer(s) or debit the equivalent amount from his/her/its account without prior notice.
- iv. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong. Any dispute arising under these Terms and Conditions shall be subject to the non-exclusive jurisdiction of the courts of Hong Kong.
- v. A person who is not a party to these Terms and Conditions may not enforce any of their provisions under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong).
- vi. In case of discrepancy between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.

B. Application for 328 Business Account Reward ("Promotion")

- 1. The promotion period for this Promotion is from 1 Oct 2025 to 31 Dec 2025 (both dates inclusive) ("Promotion Period").
- 2. The Promotion is applicable to customers who ("Eligible Customer"):
 - successfully apply for a 328 Business Account (including a 328 Current Account and a 328 Savings Account) of the Bank (except online application) during the Promotion Period and successfully open the said 328 Business Account on or before 31 Jan 2026; and
 - ii. did not maintain any 328 Business Account within 12 months prior to the account opening date.
- 3. Eligible Customers can enjoy up to HKD1,000 cash reward(s) ("Cash Reward") by fulfilling the following criteria:

Example: For an Eligible Customer who successfully open a 328 Business Account on 8 Oct 2025, the first 3 calendar months and the 4th to 6th months referred to under Reward 1 and Reward 2 for the Daily Average Deposit Balance calculation are Nov 2025 to Jan 2026 and Feb 2026 to Apr 2026 respectively.



- 4. "Daily Average Deposit Balance" refers to the average daily positive balance of all savings accounts and current accounts (held in the same name), excluding fixed deposits, of a 328 Customer, maintained with the Bank.
- 5. Reward 1 is capped at HKD200 Cash Reward. The Eligible Customer is required to settle the account opening fee upfront and upon fulfilling all the relevant requirements set forth in Clauses 2 and 3 above, the Bank will credit the Cash Reward under Reward 1 to the Eligible Customer's 328 Current Account on or before 31 Jul 2025.
- 6. Reward 2 is capped at HKD800 Cash Reward. The Eligible Customer is required to settle the account opening fee upfront and upon fulfilling all the relevant requirements set forth in Clauses 2 and 3 above, the Bank will credit the Cash Reward under Reward 2 to the Eligible Customer's 328 Current Account on or before 31 Oct 2025.
- 7. The 328 Business Account must remain valid when the Cash Reward is to be credited. Otherwise, the relevant Eligible Customer will not be entitled to the Cash Reward.
- 8. The calculation of the Daily Average Deposit Balance shall be subject to the Bank's records and final decision in the event of dispute.
